Attention is invited to Railway Board's letter No E(MPP)2019/3/44 Dt. 27/01/2020 (RBE No. 10/2020) circulated vide PS No. 12/2020 dated 11/02/2020. Initial Training Course for Apprentice Technicians (Non-ITI) of all trades was for 156 weeks according to Training Module of 2005. However, it has now been reduced to 78 weeks vide RBE No. 10/2020.

Candidates who had been sent under training for 3 years prior to issue of revised training module will complete the training after the completion of training of fresh candidates and seniority of the candidates will be affected accordingly.
