Minutes of the Meeting of Central SBF Committee held at HQ-CCG on 15/12/2021

The Member Secretary cum Dy. CPO (Wel) extended a warm welcome to the Co-Chairman, and all Members of the CSBF Committee.

Minutes on Agenda items:

1. **Re-appropriation** of 25% Amount from 'Misc' Head to the Head of '**Indigenous System of Medicine**'. As per Rly board's letter dated 18/11/2021, Remuneration to AYUSH doctors enhanced to RS.75000/- This was agreed to for 5 months. Approx. Rs. 9 lakhs.
2. Proposal received from DRM-BRC for purchase of **essential item for Children park at Bharuch Rly colony** amounting to Rs. 2,37,500 was sanctioned, with some modifications to the original proposal which will be detailed in the sanction letter to the Division.
3. Proposal received from Chairman LSBF committee BCT for **Multi Activity Play Station** equipment for **Pali Hill Railway Colony** amounting to Rs.6,04,240/- was not accepted by the Committee as there are only 20 Quarters in this Railway Colony.
4. Proposal received from Chairman LSBF committee HQ-CCG for **Upgradation of HQ Staff Canteen** amounting Rs.22,76,000/- will be considered after CPO (IR)'s inspection of the Staff Canteens.
5. Cash Imprest for CSBF meetings Rs.15,807/- was sanctioned as proposed.



6. Proposal received from DRM(E) ADI for purchasing **Items for Rly Institute Old Colony SBI** amounting Rs.10,01,247/- under the Head "Recreation other than sports" was not sanctioned. As per some members, there is not enough space in the Institute Hall for both Indoor Gymnasium as well as for holding social functions like weddings and parties. Hence it was decided that a diagram of the hall along with dimensions be called for from the Division for future consideration of the Committee.

It was also decided that a letter be sent to President WRSA and Presidents of all DRsAs that **Sports Activities** for the staff should be organized periodically and the funds granted under Sports Head should be utilized fully for the benefit of Staff and their family members.

7. Scholarship and other financial assistance cases from all Divns/Units were sanctioned for which sanction lists will be issued separately.
8. **Holiday Camps** – funds have been released to all the Divisions for organizing camps. CSBF members decided that 2 separate Camps should be planned in the month of February/March 2022.
9. **Enhancement of Amount For The Holiday Camps** was discussed. Committee considered and decided to enhance the amount for each Holiday Camp from 4 lakhs to 5 lakhs keeping in view the rise in costs.
10. Proposal for procurement of utensils items for DRM Office Staff Canteen BCT was sanctioned after modification for an amount of Rs. 80,150/- Details will be sent in the sanction letter.
