ITF WELL BEING SEMINAR

AIRF organized Well Being Seminar for Railwaymen organized at TN Vajpayee Hall, New Delhi on 6th & 7th September, 2022.

The All India Railwaymen's Federation (AIRF) is not only concerned about the mental health of the employees of the Indian Railways, but has also taken up the initiative to keep the railway personnel in good health in association with the ITF. For this, 125 first responders have been prepared by AIRF through a special training across the country, who will not only find out the reasons for stress with the employees, but will also help them to reach the mental health counsellor.



Inaugurating the Well Being programme, Railway Board Chairman V.K. Tripathi said that medicine is fine, but it is necessary for the railway workers to consider the causes of stress themselves. He said that we also need to consider eliminating the causes of stress in advance. For this, railway workers should practice yoga and meditation regularly.

AIRF General Secretary Shivgopal Mishra while addressing the programme said that I believe that the work of a railway employee is very sensitive, so if he remains under any kind of stress, then it will definitely affect his work.

He said that today when the railway employee goes to work, he goes with great joy but when he comes back he remains irritable. In such a situation, he may be troubled by the working hours or the problems of the workplace.

He said that during the Corona epidemic, when the railway employees used to take the train, at that time his entire family was worried. Anyway, bad news used to come every day during that time. In such a situation, not only the railway employees but the whole family used to live under stress. There have been incidents like suicide in many places.

This is the reason why AIRF has decided that it will now also work on the mental health of the employees. He said that by dividing the country into four parts, we have prepared 125 first responders through special training. Now through them, we will try to reach every railway employee who is under stress. For this, a toll free number will also be started soon, through which we will also be able to directly counsel the employees and their families.

Dr. Syed Asif Altaf, Coordinator of the Well Being Program at ITF, shared his experiences and gave detailed information on mental health. He said that no matter how healthy you are physically, whatever facilities you have, working condition is also good, but if you are not mentally healthy then it is natural to have a bad effect. He said that this problem is not only seen in India, but in many countries of the world. AIRF has taken this issue seriously, it is a very good thing.

Lisa Hazarika of ITF, who assisted AIRF in preparing First Responder, said that unless we accept our problems, it will not be possible to solve them. We don't quickly understand the problem of mental health, by the time we are ready for it, it is too late. The good thing is that today AIRF is not only discussing this, but is also ready to work.

DG RHS Dr Prasanna Kumar said that I have been to many places, I am seeing such an effort for the first time. This is commendable work. He said that the truth is that today 20 percent of the population is affected by this disease. In such a situation, there is a great need for its identification and proper counseling. He said that based on the feedback of the first responder, we will also try to move forward in this direction.

Ashutosh Gangal, General Manager, Northern Railway, said that since a large number of railway employees do safety related work, especially the running staff, their stress seems natural. He expressed confidence that through this program such employees would definitely get some relief.

The program was presided over by Dr N Kanhaiya, President, AIRF. He said that the Federation has accepted this program as a challenge. We will all try our best to make it a success.

Working President JR Bhosale, Treasurer Shankarrao also addressed the program. PED Deepak Peter, CMD Sugandha Raha, Dr. Ashish Sr. DMO BN Tiwari, PCPO Pramila H Bhargava, Zone General Secretary Mukesh Galav, Mukesh Mathur, P.K. Patsani, Ashish Biswas, Amit Ghosh, Women Convenor Praveena Singh, Youth Coordinator Preeti Singh and a large number of people were present. NRMU Delhi Division had a special contribution in the successful organization of the program.

Grant of financial up-gradation under MACPS to the staff appointed from the post/ cadre to another post/cadre carrying same Grade Pay/level (7th CPC)

Railway Board vide RBE No.98/2022 dated 22.8.2022 has conveyed its decision that, Appointment / Promotion from the post of Sr. Commercial Clerk (GP 2800) / Pay Level 5) to Goods Guards (GP 2800 / Pay Level 5) and sr. Commercial Clerk (GP 2800 / Pay Level 5) to Enquiry Cum. Reservation Clerk (GP 2800 / Pay Level 5) should not construed as promotion for reckoning for the purpose of grant of financial up-gradation under MACPS.



Introduction of CBT for promotion to Group B post against LDCE quota

Railway Board has issued orders vide-letter no-E(GP)2022/2/4 Dtd-06/09/2022 as regard to introduction of centralized computer based objective type Examination (CBT) for promotion to Group B post(LDCE) on Indian Railways. In accordance with the above 70% selections and 30% LDCE for promotion to Group 'B' post in all departments will be conducted through Centralized CBT w.e.f 01-01-2023.

Clarification regarding travel on RCP in AC EMU Suburban trains

WREU has represented to GM-Western Railway for grant of permission to First Class RCP holders in AC EMU Suburban trains. In this connection Western Railway administration has sought clarification from the Railway Board vide no-C.175/A(AC EMU Trains)dtd-18/01/2018 and E(Pass)768/64 BOL.IV dtd-18/05/2022. Railway Board vide its letter no-E(W)2018/PS 5-2/6 dtd-06/09/2022 has issued clarification on a reference of Western Railway for travelling on RCP in EMU suburban trains. Now employees possessing first Class/First Class A RCP are eligible to travel in AC EMU suburban trains. This matter was pursued by GS-AIRF to the Railway Board vide letter no-AIRF/88(2017) Dtd-14/06/2022.

In this matter Western Railway vide PS No.92/2022 dated 7.9.2022 has advised to all concerned on Western Railway for necessary action for permitting the First Class/First Class 'A' RCP holders in AC EMU Suburban trains.

Recruitment under Cultural cum Scout & Guide Quota

Railway Board was advised vide its letter No E(NG)II/2022/RR-2/1 dtd-27/07/2022 and 21/12/2021 to Zonal railways to pend recruitment against cultural cum Scouts & Guides quotas for the financial years 2020-21 & 2021-22. AIRF vide PNM item no-11/2022 has raised the matter in Railway Board PNM meeting and after due deliberations railway board vide its letter No E(NG)II/2022/RR-2/1 dtd-02/09/2022 and RBE No-108/2022 has advised to all Zonal Railways to process for recruitment against Cultural cum Scout & Guide Quotas for the current Financial year i.e 2022-23.

Reservation in promotion to the persons with benchmark disabilities (PwBDs) – Promotion from group 'C' to 'B'

Railway Board has issued RBE No. 97/2022 dated 18.8.2022 in terms of DOP&T OM No. 36012/1/2020-Estt.(Res.II) dated 17.5.2022 have been adopted mutatis mutandis for grant of reservation in promotion to PwBD (Persons with Benchmark Disabilities) in Indian Railways as identified by Ministry of Social Justice & empowerments' Notification No.38-16/2020-DD-III dated 4.1.2021. Accordingly reservation to PwBD will be granted on selections/LDCE for promotion to the Group 'B' posts in Indian Railways.

Online/CBT mode for Selection of ex-cadre posts of PRS & UTS organization

Railway Board vide RBE No.96/2022 dated 12.8.2022 and 99/2022 dated 22.8.2022 have issued instructions for filling up the posts of ex-cadre posts of PRS & UTS organization preferably in "Online/CBT" mode. Accordingly henceforth a single stage examination (duly including questions on Aptitude/Computer knowledge) for filling up the posts of Console Operator, Hardware Supdt., data Base Supdt., in PRS & UTS Organization.



Relaxation in the condition of acquiring higher qualifications for grant of selection grade under CAS to miscellaneous category of Teachers

On references from the Zonal Railways regarding grant of selection grade to miscellaneous category of teachers who have put in requisite years of service of senior grade but have not been granted selection grade due to non-prescription of requisite higher qualifications. In this matter after consultation with Ministry of Education (D/o) School Education & Literacy) Railway Board vide RBE No. 110/2022 dated 7.9.2022 conveyed its decision to Zonal Railways that, after completion of 12 years of service in senior grade, selection grade may be granted to miscellaneous category of teachers in Railways without insisting on higher qualification.

Exemption of Single Mother employees from the purview of Periodical Transfer to other Stations.

Railway Board vide its letter No.E(NG)I/2022/TR/19 dated 23-08-2022 addressed to All General Managers of Zonal Railway and Production Units and clarified that Single mother employee if she holds a sensitive posts cannot be exempted from the scheme of Periodical Transfer. However, she may be shifted as far as possible to a different seat in the same place/adjoining area to meet the requirements of Periodical Transfer and to avoid any hardship including school admission, surety of girl child, mental stress and tension.

Report on System for Crew review of Running Staff and modalities for Periodic balancing of staff excess/shortage.

Railway Board has constituted a Committee of ED's vide its order dated ERB-I/2022/23/07 dated 08-02-2022 to examine the present system of crew review and recommended modalities for periodic balancing of excess/shortage of staff. The Committee consisted of the following members:-

- i. ED Estt.(N)-Convenor
- ii. ED/TT(S)-Member
- iii. ED/Finance(E)-Member
- iv. TED/EE(RS)-Member

The finding of the Committee has concluded that (1) the merger cadre of Loco Pilot between Electrical/Mechanical may be implemented uniformly across all Railways. All crew may be provided training for operating both types of tractions as may be necessary keeping in mind local circumstances. Administrative control of Loco Runnning staff may be handled by a single point of command to ensure efficiency in decision making (2) Crew Review should be done on yearly basis (calendar year i.e 1st January to 31st December) duly approved by DRM. The proposal for crew review should be sent from division to HQ well in time so that sanction of GM may be obtained by 15th March and divisions may be advised to submit indents by March. (3) extend process of filling up of post of Running staff through direct recruitment by RRB's is time consuming and generally takes about 2.5 to 3 years. Crew review should be based on 3 years Traffic projection so that any vacancies in anticipated cadre strength can be filled up in planned manner.

Grant of FMA to Railway Pensioner/Family Pension-Change in Option

Railway Board vide RBE No. 137/2022 dated 27-10-2022 has conveyed its decision to all General Manager's that Railway Pensioners/Family Pensioners residing beyond 2.5 kms from Railway Hospital/Health Units and eligible for RELHS shall be allowed opportunity to avail change in option once in a life time from FMA to OPD or vice versa without linkage to change in residence.



Travel entitlement on Passess/PTOs in Train 18 (Vande Bharat Express).

Ministry of Railways has introduced Train 18 (Vande Bharat Express). But serving employees and Pensioners are not granted permission for travelling in Train 18 (Vande Bharat Express) on Privilege Passes/PRCP/Widow Passes and PTOs etc. The matter has been raised by WREU before General Manager, Western Railway vide letter No. ADI/14/2022 dated 07-10-2022 and to AIRF to raise the issue at Railway Board level. Subsequently AIRF vide its letter No. AIRF/82(172)(195) dated 31-05-2022 has represented the matter at Railway Board level for grant of travel entitlement on Privilege Passes/PRCP/Widow Passes and PTOs. Now the Railway Board vide RBE No. 136/2022 dated 28-10-2022 has conveyed Zonal Railways its decision for revised travel entitlement on Privilege Passes/PRCP/Widow Passes and PTOs on Train 18 (Vande Bharat Express) at par with Rajdhani and Shatabdi Express Trains.

Accident Free Service Awards to eligible categories

Drivers (Loco Pilots) / Motorman / Pointsman / Cabinman / Switchman / ASM / SM / Deputy S.S. / S.S. are eligible for Accident Free Service Awards (AFSA) at the time of retirement. However, it has been brought out that AFSA has not been paid to retired employees who had worked in the eligible safety categories before being promoted/posted to non eligible categories such as Traffic Inspectors/Controller/Power Controller/Group 'B' post etc. Now Railway Board vide its letter No.2022/Safety(DM)/AFSA Policy dated 26-10-2022 has clarified that staff of specified safety categories are eligible for grant of AFSA at the time of retirement based on the period of qualifying service rendered in eligible safety categories irrespective of post held by such staff at the time retirement.

Mega Blood Donation Drive

On the call of AIRF Mega Blood Donation camps organized on Western Railway in coordination with Akhil Bhartiya Terapant Yuvak Parishad (ABTYP) on 17-09-2022 on the occasion of birthday of Hon'ble Prime Minster of India. OBITUARY

QUEEN ELIZABETH-III

Elizabeth II was Queen of the United Kingdom from 6 February 1952 until her death on 8 September 2022. Her reign of 70 years and 214 days was the longest of any British monarch and the second-longest recorded of any monarch of a sovereign country. She was born on 21 April 1926 in United Kingdom

Mikhail Gorbachev

Mikhail Sergeyevich Gorbachev (2 March 1931 – 30 August 2022) was a Russian and Soviet politician who served as the last leader of the Soviet Union from 1985 to the country's dissolution in 1991.

Gorbachev believed significant reform to be necessary for survival. He withdrew troops from the Soviet-Afghan War and embarked on summits with United States president Ronald Reagan to limit nuclear weapons and end the Cold War. Domestically, his policy of glasnost ("openness") allowed for enhanced freedom of speech and press, while his perestroika ("restructuring") sought to decentralize



economic decision-making to improve its efficiency. Gorbachev is considered to be one of the most significant figures of the second half of the 20th century. The recipient of a wide range of awards, including the Nobel Peace Prize.

Mulayam Singh Yadav

Mulayam Singh Yadav was born on 22 November 1939 in Saifai village, Etawah district, Uttar Pradesh. He was an Indian politician, a socialist figure and the founder of the Samajwadi Party. He served 3 non-consecutive terms as the Chief Minister of Uttar Pradesh, and also served as the Minister of Defence, Government of India. A long-time parliamentarian, he was the Member of Parliament, representing the Mainpuri constituency in the Lok Sabha, and earlier had also represented the Azamgarh, Sambhal and Kannauj constituencies.

With a political career spanning more than six decades, being elected as the Member of Parliament (MP) for 7 times and the Member of the Legislative Assembly (MLA) for 10 times, the veteran politician was a prominent figure of his time in Indian Politics. He was often referred to as Netaji (meaning respected leader in Hindi) by party leaders and workers. He died on 10th October, 2022 in a hospital in Gurgaon.

A.D.Nagpal

Comrade A D Nagpal (88 years), Secy HMS left for heavenly abode on 4th October, 2022 in the Hospital at Chandigarh. This is a big loss to HMS and Indian Trade Union Movement. He devoted more than 60 years for the service of workers and socialist movement. He was retired from LIC and Leads the trade union of LIC ,PF federation, Member CBT, Member of the PF Executive Committee & Coal Unions. He was the very close associate of Top Leaders of Socialist movement. He was also leader of Punjab, Haryana and other sectors trade Unions. WREU called for a condolence meeting on 7th October, 2022 at Grant Road office. Com. J.R.Bhosale and other comrades paid rich tribute to the departed leader.

Advocate Sukhdev Kashid, Sr. Leader of Municipal Mazdoor Union breathed his last on 01-09-2022 at the age of 62 years after a brief illness. He joined union in 1982. He was having thorough knowledge about the Labour Laws and represented cases of members in Court of Law successfully.
