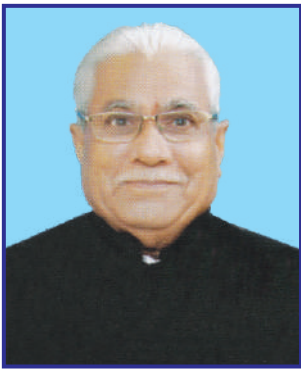




### From the Desk of Editor



#### Dear Subscribers and Railwaymen,

A Joint Forum for Restoration of Old Pension Scheme has been formed on 21-01-2023 in a Special Convention of delegates from Defense employees organization, Confederation of Postal, Income-Tax, Excise, Atomic energy and other Government employees AIRF, NFIR, State government employees, Teachers, Corporation and Semi-Government/State employees participated. As such General Secretary/WREU represented the matter to GM(E)-CCG vide its letter No.RJT/5/2022 dated 28-09-2022 and also raised the issue in the PNM Meeting vide GM

PNM Item No.58/2022. After detailed deliberation on the matter in PNM forum GM(E)-CCG has sort clarification from DRM(E)-RJT vide its letter No. ET/839/SM/RJT/WREU-58/2022 dated 28-10-2022 in response DRM(E)-RJT has given clarification vide its letter dated ET/1025/1 Vol I SM(LDCE) dated 07-12-2022. Subsequently the GM(E)-CCG has referred the matter to Railway Board vide letter No.ET/1025/4/SM dated 04-01-2023 in terms of RBE No.38/2001 and 123/2002.
