> Sub: GDCE-CBT for the post of Junior Clerk- Difficulty faced by the candidates who have been passed CBT. Ref:

1) GDCE Notification No. 1/2019 for the post of Junior Clerk cum Typist

2) Provisional Panel - Part-1 declared/published on 14-06-2023

We would like to solicit your attention on the above and seek remedial action for filling up of all vacant posts of Junior Clerk cum Typist published vide GDCE Notification No.1/2019 as assured in the PNM meeting.

It is reiterated that RRC-Western Railway, Mumbai has published notification vide No. cited under reference (1) for filling up 105 posts of Junior Clerk cum Typist through GDCE from the eligible serving candidates of Western Railway.

As you are aware that the administration has faced difficulties for completing the task of filling up all notified posts against GDCE Notifications in Level-6, Level-5, Level-4, Level-3, Level-2 etc. due to dubious reasons and happenings.

It is highly appreciable that the administration has assured in the PNM meeting that all vacant posts published through GDCE will be filled up as soon as possible. In case of Junior Clerk cum Typist 105 posts have been notified vide Notification cited under reference (1) and total 863 candidates (8 times of vacancies) have been called for typing test. Out of which majority of the candidates have been empaneled in the Panel of Level-6, Level-5, Level-4 and Level-3 as a result a provisional short panel of 6 candidates have been declared on 14-06-2023 hence, 99 posts of Junior Clerk cum Typist remained vacant.

The administration while making candidates eligible for typing test have taken action in very early stage which resulted into the candidates who qualified in the typing test have been placed on the panel of higher level -6, 5 & 3. In our view after completion of all above panels the typing test should have been conducted at later stage and candidates 1:8 should have been made eligible who have opted for the post of Junior Clerk only. According to our information there are number of candidates available who have qualified in CBT can be considered for the post of Junior Clerk. The union therefore suggests a 2<sup>rd</sup> typing test should be conducted by making eligible 99x8 times lower merit candidates who have not appeared earlier for the typing test. Similar action can be taken for completing the panel for the post of TNC (18 posts) from the candidates who have qualified in CBT and given option for the post of TNC.

In view of the above circumstances, you are requested to examine the matter and do the needful for filling up all these 99 vacant posts of Junior Clerk cum Typist amongst the candidates who have been passed the CBT but not included in the above 863 candidates who were called for Typing Test. These CBT passed candidates may be called for typing test so as to fill up all vacant post of Junior Clerk cum Typist as assured by the administration.
