As the railway administrations are aware, the recruitment process for filling up the vacancies in Level 1 and above in various categories is being completed for alloting RRB/RRC empanelled candidates to the Zonal Railways / PUs etc. One of the staff Federations has requested to facilitate the inter railway transfer applicants joining new units on transfer alongside filling these slots by empanelling RRB/RRC candidates.

It is advised that the Railways may make use of the opportunity being presented by way of the large panel for considering the transfer applications. The transfer cases may be processed wherever feasible, while keeping the operational requirements in mind.

Dear Shri Misra,

I would like to draw your attention to instructions contained in Board's letter no. E(NG)I-2018/TR/18 dated 11.01.2019 on the subject of mutual transfers of non-gazetted staff on the Zonal Railways. Chairman, Railway Board in his last address had directed for liquidation of all mutual transfer cases.

In case of mutual transfer, once the NOC has been given by both the Railways/Units i.e. accepting and relieving, both the employees should be spared immediately within a week, without either unit waiting for the reliever, normally with the senior employee being relieved first.

It has been noticed from the position furnished by the Zonal Railways/ PUs in the Google Sheet and HRMS, that cases of mutual transfer are not being finalized expeditiously. May I request you to kindly have the matter looked into on priority and arrange to get all the pending cases within and across Railways cleared at the earliest as there is no reason to pend such cases. It may please be ensured that that in mutual transfer cases, where NOC has been given by both the Railways/Units i.e. accepting and relieving, the transfer order may be issued without any delay and employees concerned should be relieved immediately. This will be the responsibility of Branch officer/Head of Department concerned under whom the staff is working. It is also expected that all such cases are now processed using the newly developed HRMS transfer module.

It is also reiterated that Personnel Department concerned should ensure that the physical service records and Last Pay Certificate (LPC) should also be sent within 15 days without fail. All other terms and conditions regulating mutual transfer of railway employees will continue to remain in force.

I would like you to personally look into the matter and ensure that all such pending mutual transfer cases on your Railway/PU be disposed off at the earliest by launching a special drive, and status report sent by 07.01.23.
